I/We hereby request from Tyee Propane Ltd. a Credit Account. I/We authorize the exchange of all necessary credit information, and consent to the release of all information pursuant to the Freedom of Information and Protection of Privacy Act.

CREDIT AND SECURITY TERMS:

Due on receipt; Net 15 days. Service charge will be charged at the rate of 2% per month (effective rate of 26.82% per annum) on all overdue accounts. Where business is conducted by a limited company, the applicant guarantees payment of all amounts outstanding by the company to Tyee Propane Ltd. ("Supplier"). The terms of any Application for Credit or Invoice signed by the Customer apply to all Invoices, products and services, these terms are deemed to have been accepted. In the event of any actions or proceedings to collect any amount due, the Customer agrees to pay all legal fees and collection costs (and hereby grants to the Supplier a full indemnity for all legal and other expenses), all court costs and all seizure and sale costs. The Customer hereby grants to the Supplier a security interest over all goods supplied to the Customer and over all of the Customer's present and after acquired personal property and assets as security for the payment and performance of all obligations to the Supplier from time to time. The Customer hereby waives its right to receive any financing statement or verification statement relating to any registration of the security interest herein, Title to the goods, remains in the Supplier, and all proceeds of the sale shall be held in trust by the Customer for the Supplier until the indebtedness due to the Supplier is paid in full."
